Small grants are made to audiology graduate students who are conducting research as part of their academic coursework, and larger grants are made to post-docs in early stages of their research careers in hearing and balance science.

(Revenue \$) Education: Support for educational and public awareness programs of the American Academy of Audiology and other hearing health organizations. Programs supported included live and web-based education in pediatric audiology, private practice and patient care, next-generation leadership and student programs, and the DiscovEARy Zone for public outreach on hearing health and conservation. Expenses also include those incurred for the Foundation's education and public awareness programs.
